LIFETIME WARRANTY

Phylrich warrants that its products *and their finish* are free from manufacturing defects in materials and workmanship for the life of the fixture, if purchased after 1996.

With respect to accessories or component assemblies which are not manufactured by Phylrich, the warranty obligation of Phylrich shall not exceed the warranty extended to Phylrich by the original manufacturer of such accessory component.

This warranty applies to the original owner only and is not transferable.

What is not covered:

- 1. Damage caused by accident, negligence, misuse, abuse, improper operation or failure to follow care instructions enclosed with your product.
- 2. Damage occurring during shipment of the product (claims must be presented to the carrier)
- 3. Damage resulting from repair or attempt to repair the product not authorized by Phylrich.
- 4. Normal wear and maintenance.
- 5. Labor charges and other costs of removal and reinstallation.
- 6. Freight charges to and from Phylrich.

What you must do to obtain Warranty Service:

- 1. All warranty claims must be processed where the product was purchased.
- 2. You are responsible to produce a proof of purchase.
- 3. Product shipped must be packaged securely. You are responsible for any shipping damage

This limited warranty does not assume liability for any obligation other than the repair or replacement, at the option of Phylrich, of the defective product upon presentation thereof to Phylrich during the warranty period.

THIS LIMITED WARRANTY MAY NOT BE ALTERED, VARIED, OR ESTENDED, EXCEPT BY A WRITTEN INSTRUMENT EXECUTED BY PHYLRICH THE REMEDY OF REPAIR OR REPLACEMENT AS PROVIDED UNDER THIS LIMITED WARRANTY IS EXCLUSIVE. IN NO EVENT SHALL THE MANUFACTURER BE LIABLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES TO ANY PERSON, WHETHER OR NOT OCCASIONED BY NEGLIGENCE OF PHYLRICH, INCLUDING WITHOUT LIMITATION DAMAGES FOR LOSS OF USE, COSTS PROPERTY DAMAGE OR OTHER MONETARY LOSS.
