
The Taco Hydro-Sep™ hydraulic separator is the ideal piping companion for today's widespread usage of Primary Secondary piping. By installing the efficient and compact Taco Hydro-Sep piping errors can be prevented, installation time reduced and valuable mechanical room space saved. On systems using boilers with higher pressure drops, the hydraulic separator allows for the possible use of a smaller zone circulator because it is not required to overcome the additional head loss associated with the boiler. At the same time the boiler pump can maintain constant flow through the boiler. The Hydro-Sep also has the added benefits of venting air by means of the Taco Hy-Vent® and sediment removal via the bottom valve.


PRESSURE / TEMPERATURE CHART



INSTALLATION:

CAUTION: Do not shorten the Hydro-Sep's factory configured connections.

TYPICAL INSTALLATION



The Hydro-Sep must be installed with the body portion in a vertical position, with the Hy-Vent on top. Either side of the Hydro-Sep may be the primary or secondary connections. The supply and return piping of each circuit must be on the same side. The position of the supply and return connection must be the same on both sides (i.e. boiler supply and zone supply both connected to the top ports. Boiler supply and return connections on the left side.) Loosen the vent cap to automatically vent accumulated air. tighten down the cap to close during system purging. Vents left in the automatic position should use a Taco waste connector when leaking water from a failed vent could cause water damage. This product should be installed by professionals familiar with the correct function and performance of hydronic heating piping systems. During yearly system service use the bottom valve to remove any system sediment that has accumulated in the Hydro-Sep. WARNING: Use caution as the system fluid may be very hot!

LIMITED WARRANTY STATEMENT

Taco, Inc. will repair or replace without charge (at the company's option) any product or part which is proven defective under normal use within one (1) year from the date of start-up or one (1) year and six (6) months from date of shipment (whichever occurs first).
