




AdobeAir Residential Roof Mounted and Window Mounted Evaporative Cooler 8-Year Limited Warranty

AdobeAir, Inc., Phoenix, Arizona, extends this limited warranty to the original purchaser of an AdobeAir Evaporative Cooler installed and used under normal conditions within the continental United States.

- I. Eight Year Coverage applies to base assembly of cabinet only. Should any water leakage occur through the base assembly due to rust out during the first eight years after date of initial purchase, the cabinet will be replaced with the following prorated cost to the purchaser (based on original sales receipt from initial purchase).

Credit will be allowed based on the original purchase price of the cabinet only, excluding accessories and installation charges.

- II. One Year Coverage applies to all other components (except cooler pads) and accessories furnished by AdobeAir. We will exchange the part (except cooler pads) which fails as a result of a defect in material or workmanship during the first year after date of initial purchase.
- III. What this warranty does not cover:
- A. This warranty does not cover any failure, damage or defect that results from unauthorized modification or service; or from the use of products or replacement parts other than those from AdobeAir; including, but not limited to, motors and pumps.
 - B. This warranty does not cover any damage or malfunction unless caused by a defect in material or workmanship. Damage or malfunction which is not covered by this warranty includes, but is not limited to, water damage to the motor, abuse, misuse, alteration, improper installation/maintenance/operation/transportation damage.
 - C. This warranty does not cover replacement of cooler pads. Cooler pads are disposable items and their life expectancy depends on local conditions.
 - D. This warranty does not cover the cost of a service call at the site of installation to diagnose cause of trouble, the cost of labor to install the part, or mileage allowance to or from the site. AdobeAir does not pay freight/postage on any exchange.
 - E. This warranty does not cover evaporative coolers installed and operated outside the continental United States.
- IV. **Do not use cooler cleaners, cooler treatments, or other additives in this evaporative cooler. The use of any of these products will void your warranty and may impair the life of your evaporative cooler.**
- V. To obtain service under this warranty, contact the dealer where you purchased your evaporative cooler. As a final step, if you cannot locate your dealer, contact Customer Service, AdobeAir, Inc., 500 South 15th Street, Phoenix, Arizona 85034.
- VI. In case of unsatisfactory warranty service, please write Customer Service, AdobeAir, Inc. Include your name, address and ZIP code, the servicing dealer involved, the model number of your evaporative cooler, date of installation, and a description of your problem.

This warranty is the only warranty extended by AdobeAir to suppliers and/or purchasers of this evaporative cooler. AdobeAir disclaims all other warranties, express or implied, that arise by the operation of the law, except that implied warranties of merchantability or fitness for a particular purpose are limited to the duration of the warranty period. AdobeAir shall not be liable for any incidental or consequential damage which may have resulted from any alleged breach of warranty.

Some states do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages, so the limitations or exclusions stated above may not apply to you.

This warranty gives you specific legal rights and you may have other rights which vary from state to state. Since AdobeAir, Inc. follows a policy of continuous product improvement, it reserves the right to change design and specifications without prior notice or liability.
