4. First-Aid Measures

5. Fire-Fighting Measures

UNUSUAL FIRE AND EXPLOSION HAZARDS: Water spray may be ineffective. Closed containers may explode when exposed to extreme heat due to buildup of steam. 6. Accidental Release Measures

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED: Contain spilled liquid with sand or earth. DO NOT use combustible materials such as sawdust. Isolate the hazard area and deny entry to unnecessary and unprotected personnel. Remove all sources of ignition, ventilate area and remove with inert absorbent and non-sparking tools. Dispose of according to local, state (provincial) and federal regulations. Do not incinerate closed containers. Ventilate area, isolate spilled material, and remove with inert absorbent. Dispose of contaminated absorbent, container, and unused contents in accordance with local, state, and federal regulations.

7. Handling and Storage

Store large quantities in buildings designed and protected for storage of flammable aerosols. Keep away from heat, sparks, flame and sources of ignition. Avoid excess heat. 8. Exposure Controls / Personal Protection

PERSONAL PROTECTION

ENGINEERING CONTROLS: Provide general dilution of local exhaust ventilation in volume and pattern to keep TLV of hazardous ingredients below acceptable limits. EFFECTS OF OVEREXPOSURE - INHALATION: Harmful if inhaled. High gas, vapor, mist or dust concentrations may be harmful if inhaled. Avoid breathing fumes, spray, vapors, or mist. Crystalline Silica is also listed by the NTP as a known human carcinogen. Constituents may also contain prismatic tremolite as an impurity, and sufficient exposure to respirable prismatic tremolite dust may cause serious lung problems.
