The FireLock Expansion Plate for V27, V34, and V36 recessed sprinklers is designed to allow a minimum of 1" lateral clearance between the sprinkler and ceiling opening. The expansion plate meets most clearance requirements for seismic applications. Refer to local building codes and the Authority Having Jurisdiction for specific seismic requirements.

The FireLock Expansion Plate is compatible with all V27, V34, and V36 recessed sprinklers. The addition of the expansion plate does not affect the takeout dimensions of the V27, V34, or V36 recessed sprinkler model being installed. Use of the FireLock Expansion Plate does not alter Listings and Approvals of the V27, V34, or V36 recessed sprinklers.

The FireLock Expansion Plate for V26, V27, V36, V38, and V39 concealed sprinklers is designed to allow a minimum of 1" lateral clearance between the sprinkler and ceiling opening. The expansion plate meets most clearance requirements for seismic applications. Refer to local building codes and the Authority Having Jurisdiction for specific seismic requirements.

The FireLock Expansion Plate is compatible with all V26, V27, V36, V38, and V39 concealed sprinklers. Please note, the addition of the concealed expansion plate does affect the takeout dimensions of the V26, V27, V36, V38, or V39 concealed sprinkler model being installed. See concealed sprinkler plate dimensions on page 2. Use of the FireLock Expansion Plate does not alter Listings and Approvals of the V26, V27, V36, V38, or V39 concealed sprinklers.

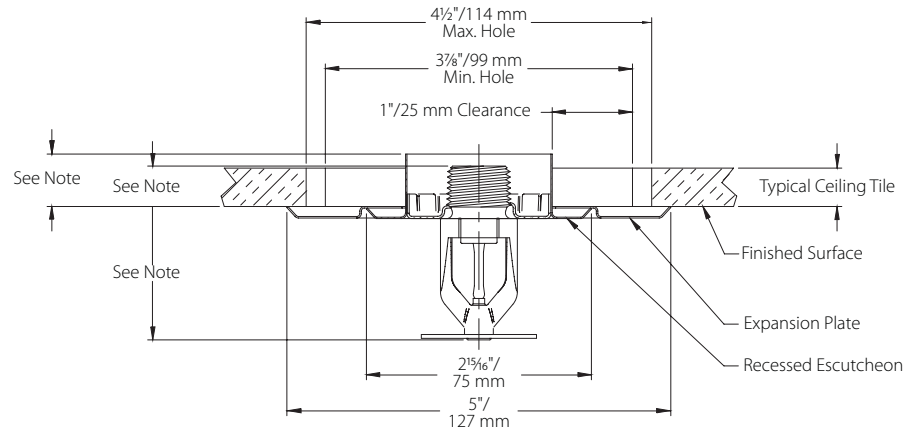

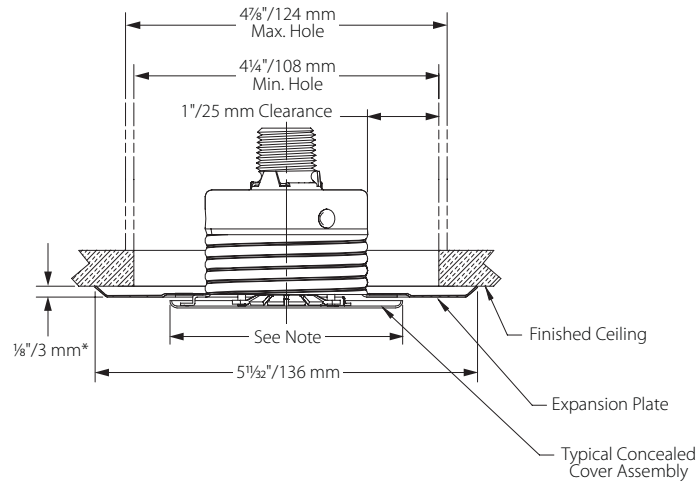
Recessed Sprinkler Plate
