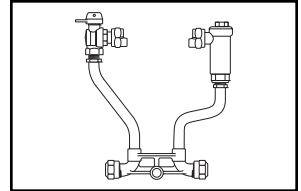


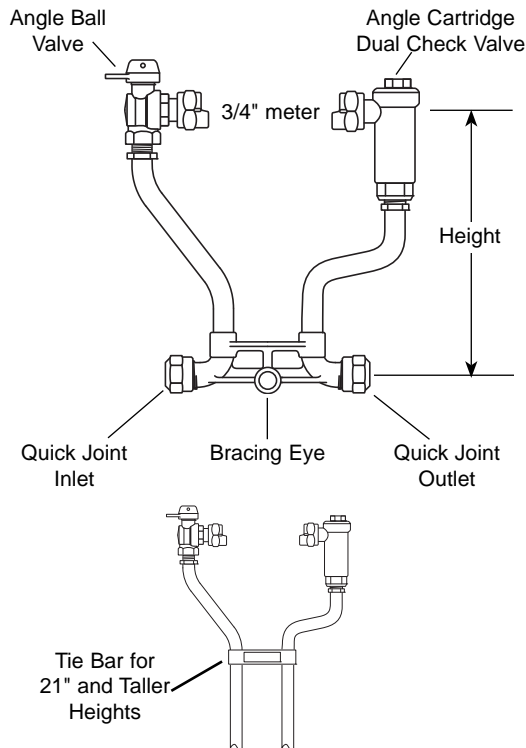

- ASSE 1024 approved Dual Check Valve
