Limited Warranty for First Five Years

Limited Warranty for Operating Controls and Cables

Warranty work will be performed when the steam generator portion of the Mr.Steam Product is returned to the location designated by Mr.Steam.

This limited warranty is non-transferable and applies only to the original consumer purchaser.
