

ASPEN LIMITED PRODUCT WARRANTY

Residential Coils, Manufactured Housing Coils

COMPLETE COIL WARRANTY

Aspen Manufacturing I, Ltd. (Aspen) warrants to its direct purchasers that Coils sold to them shall be of a merchandisable quality, free of defects in material or workmanship, under normal use and service for a period of five (5) years from date of manufacture OR five years from date of installation, NOT to exceed six (6) years from date of manufacture. If a claim is made during the sixth year, documentation of installation date must accompany the claim. Aspen warrants its Coated Galvanized Steel Drain Pans for a period of five (5) years from date of manufacture and its Stainless Steel Drain Pans for as long as the original end user owns the property in which the Drain Pan is installed.

Coils and Drain Pans covered by this warranty found to Aspen's satisfaction to be defective upon examination at an Aspen factory or authorized service center will, at Aspen's option, be repaired or replaced and returned to the buyer via lowest common carrier or alternatively, Aspen may at its option, grant the buyer a credit for the replacement value of the defective article at the time of the claim. Upon return of defective Coils or Drain Pans to Aspen's factory or authorized service center, freight prepaid by the buyer, correction of such defect by repair or replacement, return via lowest common carrier, and, in cases of Coil defect, the payment of a fifty dollar (\$50) labor allowance credit to the buyer, shall constitute full performance by Aspen of its obligation hereunder.

Aspen shall have no liability for expenses incurred for repairs of start-up refrigerant leaks, since Coils that are not pressurized should not be installed. Aspen shall have no liability for expenses incurred except by prior written authorization. Every claim on account of Breach of Warranty shall be made to Aspen in writing within the warranty period specified above, otherwise such claim shall be deemed waived. Aspen shall have no warranty obligation whatsoever if its products have been subjected to alteration, misuse, negligence, corrosive atmosphere, free chemicals in system, accident, or if operation is contrary to Aspen's recommendations.

THE FOREGOING IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED,

NOTWITHSTANDING THE PROVISIONS OF THE UNIFORM COMMERCIAL CODE, THE MAGNUSON-MOSS WARRANTY--FEDERAL TRADE COMMISSION IMPROVEMENT ACT, OR ANY OTHER STATUTORY IN COMMON LAW, FEDERAL OR STATE.

ASPEN MAKES NO WARRANTY, EXPRESS OR IMPLIED, OF FITNESS FOR ANY PARTICULAR PURPOSE, OR OF ANY NATURE WHATSOEVER, WITH RESPECT TO PRODUCTS MANUFACTURED OR SOLD BY ASPEN HEREUNDER, EXCEPT AS SPECIFICALLY SET FORTH ABOVE AND ON THE FACE HEREOF. IT IS EXPRESSLY UNDERSTOOD AND AGREED THAT ASPEN SHALL NOT BE LIABLE TO BUYER FOR ANY INCIDENTAL, CONSEQUENTIAL, OR PENAL DAMAGES, OR FOR ANY EXPENSES INCURRED BY REASON OF THE USE OR MISUSE BY BUYER OR THIRD PARTIES OF SAID PRODUCTS. TO THE EXTENT SAID PRODUCTS MAY BE CONSIDERED "CONSUMER PRODUCTS" AS DEFINED IN SEC. 101 OF THE MAGNUSON-MOSS WARRANTY--FEDERAL TRADE COMMISSION IMPROVEMENT ACT, ASPEN MAKES NO WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, TO END USERS, EXCEPT AS SPECIFICALLY SET FORTH ABOVE AND ON THE FACE HEREOF.

ALL CLAIMS RELATING TO OR ARISING OUT OF THE OPERATION OF THIS PRODUCT ARE SUBJECT TO BINDING ARBITRATION UNDER THE AUSPICES AND RULES OF THE AMERICAN ARBITRATION ASSOCIATION.
